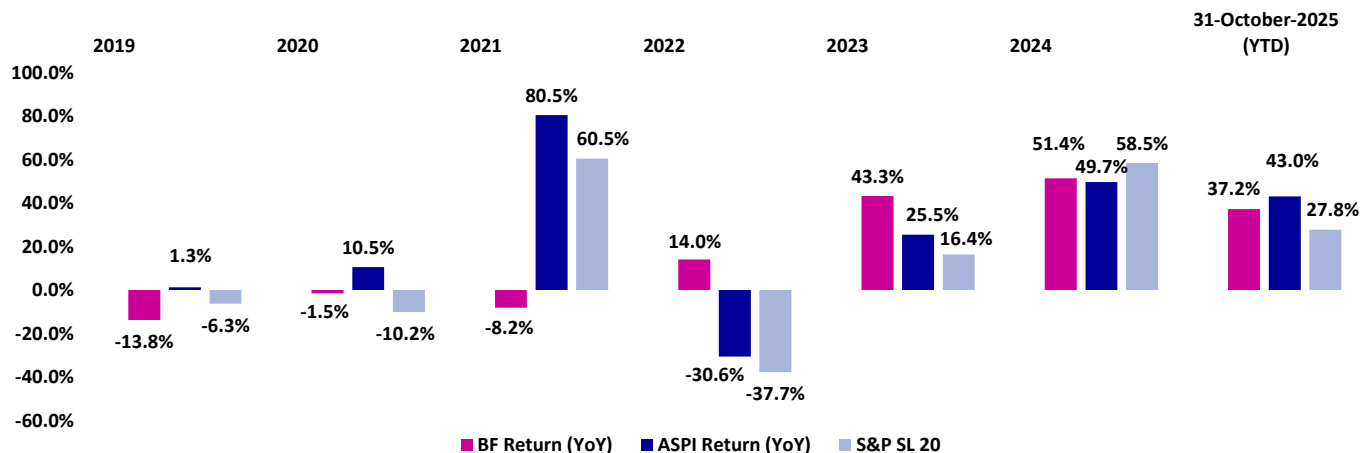
## Fund Performance

The year to date unannualized return is 37.2% (31 Dec 2024 - 31 October 2025).

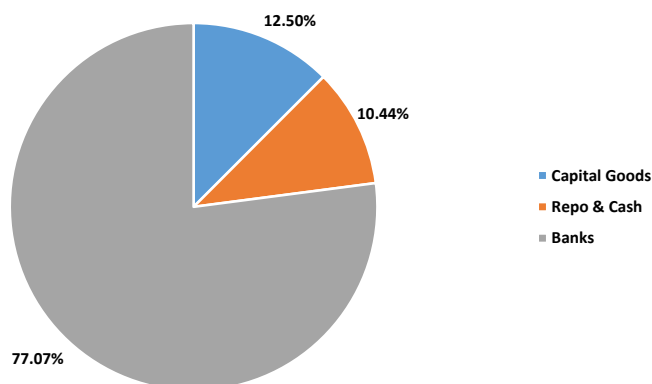
For this month compared to the previous month, the return on Colombo Stock Exchange with ASPI increased by 4.7% while S&P 20 increased by 1.4%. The Capital Alliance Balanced Fund increased by 2.9%.

As at the last week, the ASPI and S&P 20 indices have a Year-to-Date earning of 43.1% and 28.9%, respectively, while the fund increased by 38.3%

#### Key risks of the fund
