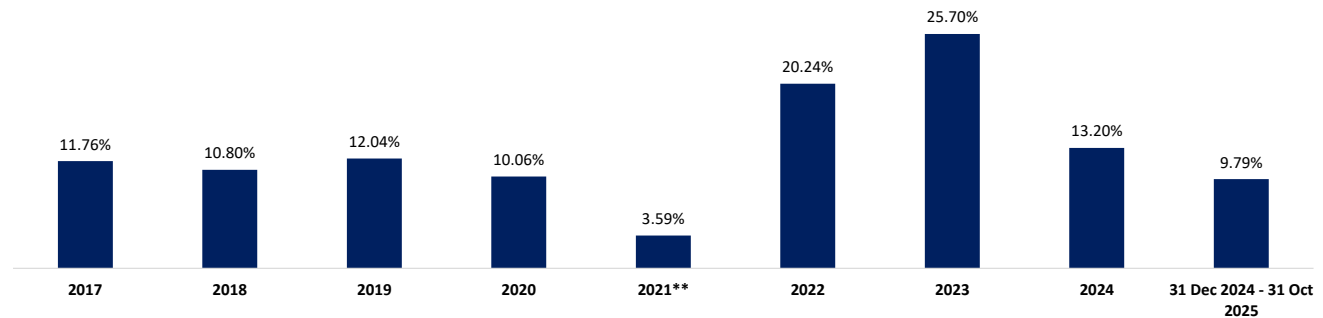

The year to date Return is 9.79% (31 Dec 2024 - 31 October 2025). It tells investors what the fund would yield in a year, based on the returns earned year to date.

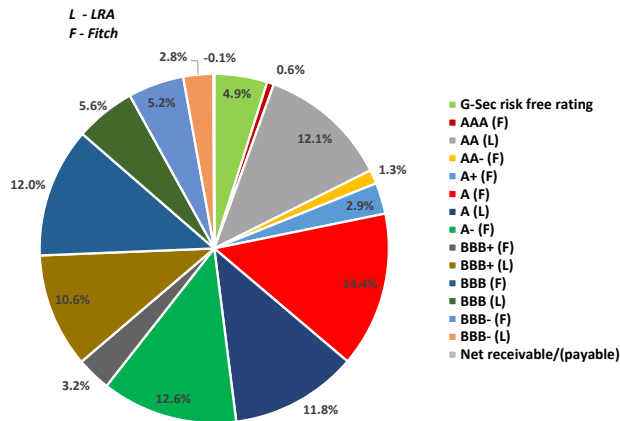

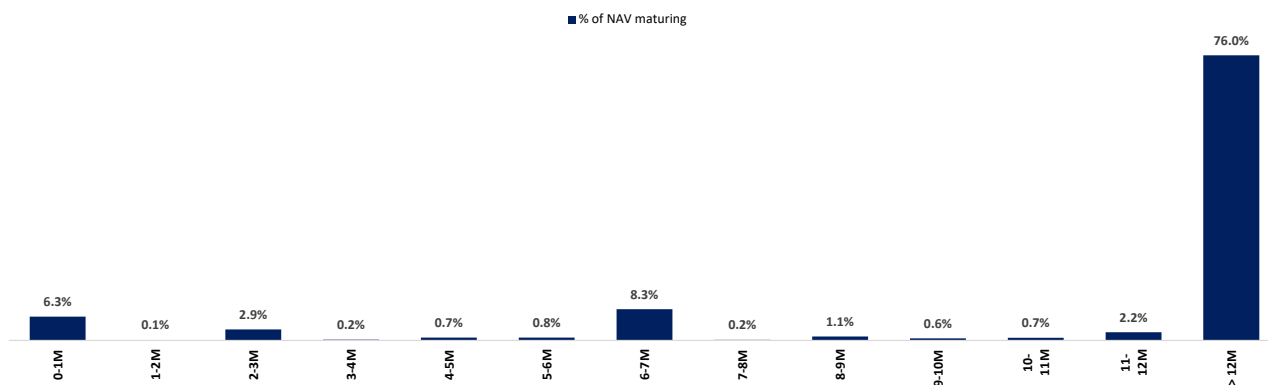
