
## Fund Performance

The year to date unannualized return is 39.1% (31 Dec 2024 - 28 November 2025).


For this month compared to the previous month, the return on Colombo Stock Exchange with ASPI decreased by 0.4% while S&P 20 increased by 0.9%. The Capital Alliance Balanced Fund increased by 1.4%.

As at the last week, the ASPI and S&P 20 indices have a Year-to-Date earning of 44.1% and 30.9%, respectively, while the fund increased by 40.9%

#### Key risks of the fund
